# **MEMORANDUM OF UNDERSTANDING (MOU)**

**CONCERNING** 

ACADEMIC COLLABORATIONS AND COMMUNITY OUTREACH PROGRAMS

**DARRANG COLLEGE and OMEO DAS H.S. SCHOOL**, both hereinafter referred to as "Cooperating Parties", fully recognizing that educational exchanges and cooperation between the Cooperating parties would be beneficial to all concerned, hereby affirm their intention to encourage such exchanges and cooperation.

As a general declaration of intent, Darrang College and Omeo Das H.S. School have agreed to the following:

- 1. The Cooperating parties shall encourage the following activities for the students and Teachers cross-cultural understandings and community empowerment:
  - a) Conducting outreach programs in education, skills development, and awareness campaigns to school's adjacent communities.
  - b) Development of academic activities in the school for rural empowerment
  - c) Academic adoption of the school for offering academic support to students.
  - d) Offering technical support to the Innovation Club of Omeo Das H.S. School by the Institution's Innovation Council (IIC) of Darrang College for Innovation and entrepreneurship development.
  - e) Promoting and encouraging joint projects on sustainable development, health and environment.
  - f) Conducting training programs and guest lectures for students, in which college faculty may deliver guest lectures at the school.
  - g) other areas as mutually agreed upon by the parties.
- The aforementioned activities shall be realized by means of consultation and the exchange of relevant information between appropriate members of the two institutions.
- 3. The MOU shall be effective upon signature by both the parties, for a period of 5 (five) years from the date of signature. The MOU may be extended beyond the period upon mutual consent of the Cooperating Parties.
- 4. This MOU may be terminated by **Darrang College and Omeo Das H.S. School** upon written notice to the other party and shall terminate 30 (thirty) days after receipt of such notice from the parties.
- 5. Without prejudice the foregoing steps shall be taken to ensure that the termination of this MOU will not compromise or discriminate against any of the activities or programme undertaken within the MOU framework.

### AMENDMENT:

The MOU may be amended at any time by written agreement of both the parties.

#### SETTLEMENT OF DISPUTES:

Any dispute, controversy or claim arising out of the MOU or the breach. termination or invalidity thereof which cannot be settled through direct negotiations, will be amicably settled through reconciliation.
