MEMORANDUM OF UNDERSTANDING (MoU) BETWEEN ASSAM DARRANG COLLEGE AND RCHOBBYTECH SOLUTIONS PVT LTD

This Memorandum of Understanding ("MoU") is made and entered into on this (Date: 21-05-2025) by and between:

1. **DARRANG COLLEGE**, an educational institution located in Assam, hereinafter referred to as "DC";
2. **RCHOBBYTECH SOLUTIONS PVT LTD**, an organization specializing in drone technology and training, hereinafter referred to as "RCH";

collectively referred to as "Parties" and individually as "Party."

1. PURPOSE

This MoU establishes a non-commercial partnership between DC and RCH to collaborate in offering drone technology-based short-term and long-term courses, and in setting up drone laboratories and Centres of Excellence (CoEs) in the future.

2. SCOPE OF COLLABORATION

2.1 Short-Term Courses

- RCH shall offer short-term training programs on drone technology, including programming, operations, and applications.
- These courses shall be open to students from DC as well as other educational institutions.
- Certification for these courses shall be provided by RCH in association with DC.

2.2 Long-Term Courses

- RCH shall offer long-term training programs focused on advanced drone technology, research, and application development.
- These courses shall be exclusive to students enrolled in DC.
- Certification for these courses shall be provided jointly by DC and RCH.

2.3 Establishment of Drone Labs and Centres of Excellence (CoEs)

- RCH and DC shall collaborate to establish drone laboratories and CoEs within DC.
- These facilities will serve as hubs for research, innovation, and skill development in drone technology.
- Both Parties shall explore opportunities for grants, sponsorships, and other funding sources to develop these facilities.

3. RESPONSIBILITIES OF THE PARTIES

3.1 Responsibilities of DC

- Provide necessary infrastructure and space for conducting courses and setting up drone labs/CoEs.
- Facilitate student participation in courses and research activities.
- Support RCH in promotional and outreach activities related to drone training.

3.2 Responsibilities of RCH

- Design and conduct short-term and long-term courses on drone technology.
- Provide technical expertise, trainers, and necessary equipment for training and research purposes.
- Assist DC in the establishment and management of drone labs and CoEs.

4. GENERAL TERMS

- This MoU is non-commercial in nature and does not involve any financial obligations on either Party unless separately agreed upon in a written agreement.
- A separate Memorandum of Understanding (MoU) will be signed to outline the financial share between DC and RCH
- The collaboration shall be valid for a period of 5 years from the date of signing and may be extended upon mutual agreement.
- Any disputes arising from this MoU shall be resolved amicably through discussions between the Parties.
- This MoU does not create any legal or binding obligations beyond the stated terms of collaboration.

5. TERMINATION

Either Party may terminate this MoU by providing 60 days' written notice to the other Party. In such an event, both Parties shall ensure an orderly conclusion of ongoing activities.


