This agreement is made on 13<sup>th</sup> Day of June, 2025 between the Darrang College, a government-aided educational institution in Tezpur, Pin-784001 hereinafter called "College", as the first party and the Edupur Foundation, asocial service Non-Governmental Organization of Tezpur, Pin-784001, as Second Party.

## 1. PURPOSE OF MOU

The Purpose of this Memorandum of Understanding (MOU) is to establish a working arrangement between the College and Edupur to assist the development of professional skills of students by aiding career counseling, training, providing courses and assist in employment opportunities to the students. By this MOU two parties agree to cooperate for greater benefit of students by creating post education job opportunities in the corporate sectors. This MOU represents a non-binding expression of Intent between the parties to work together to promote skill training and education, placement of students in suitable Industry as working professionals.

## 2. BACKGROUND

## **Darrang College**

Established in 1945 by the people of Tezpur, Darrang College was permanently affiliated to Gauhati University in 1953. With the motto of "Be a Jewel among men", it has been uninterruptedly working for fruitful dissemination of knowledge to its pupils with the solemn aim of making them worthy citizens of the country. The claim has been vindicated by a large number of alumni glittering in the national and international arena.

The National Assessment and Accreditation Council of India (NAAC), UGC, in its Reaccreditation (3rd Cycle) has awarded the Institution the prestigious CGPA of 2.68 on a four-point scale at B+ Grade (valid from 27th March 2019 to 28th March, 2024).

Teaching is based on lectures, seminars, tutorials, remedial methods and assignments. Teaching takes place in well-equipped classrooms, galleries and laboratories with the required support systems. Seminars, tutorials, remedials and assignments supplement the lectures in a way that enhances the learning experience.

## 3. COLLABORATIVE OBJECTIVES AND ACKNOWLEDGMENT

Both the parties agree to provide awareness training, skill development courses, placement & career counseling to the students of the college and other district candidates, enabling them a clearer vision and career prospective as well as provide them a platform by collaborating with companies looking for recruitment.

#### 4. WORKING AGREEMENT

Both the parties agree to share their specific expertise regarding bridging the unemployment gap through skill training. To facilitate this collaboration, the parties agree to share student database, success stories, career counseling, placement drive, time-to-time workshops to the students.

## THE COLLEGE HAS FOLLOWING MANDATE

- 1) To introduce Skill Development Courses/ Career Counseling/Placement Cell.
- II) To provide classroom or conference hall and computer lab for skill training courses.
- III) To provide time-to-time announcements of trainings.
- IV) To provide adequate facilities to bring in on-campus skill development courses.
- V) To give wide publicity regarding the courses provided by edupur.

#### THE EDUPUR HAS FOLLOWING MANDATE

- 1) To provide Skill Development courses for the college students.
- II) To provide Career Counseling to the college students.
- III) To provide Training and Placement assistance for the college students.

### 5. TIME FRAME WORK

The MOU will be effective from  $\frac{13}{106}$  to 3 years from the signing of the MOU.

## 6. GENERAL

- A. This MOU is strictly for internal management purposes for each of the parties. It is not legally enforceable and shall not be construed to create any legal obligation on the part of either party. This MOU shall not be construed to provide a private right or cause of action for or by any person or entity.
- B. This MOU will be in effect for a period of 3 years and can be renewed by written agreement of both parties. It can be terminated by either party at any time by providing notice in writing to the other party.
- C. This MOU in no way restricts either of the parties from participating in any activity with other public or private agencies, organizations or individuals.
