### **2. Documents Required/General Guidelines**

**A.** Applicants must bring the downloaded **Acknowledgement of Darpan Portal** along with photocopies of the following documents:

- HSLC Marksheet (Original & Photo copy to be submitted)
- HSLC Admit Card (Original & Photo copy to be submitted)
- Birth Certificate (Original & Photo copy to be submitted)
- Aadhar Card (Original & Photo copy to be submitted)
- Caste Certificate (if applicable)
- Income Certificate (if applicable)
- Gap Certificate (if applicable)

**B.** All original documents viz. Marksheet, pass certificate, Caste Certificate, proof of Age, Gap certificate (if applicable), etc., must be produced at the time of admission for verification.

**C.** Gap Certificate (if applicable). A maximum gap of 3 years is permissible, and Gap certificate must be issued by the competent authority or Affidavit is acceptable. **For more than 3 years gap prior permission of the AHSEC is required.**

**D.** Applicants of Other States (except Assam) cannot avail the free Admission facilities.

**E. Publication of Names in the merit/selection list does not confirm final selection for admission.**

3. **Admission:** Admission will be from the merit list of DARAPAN. Students from Waiting list will be offered admission on the same day after completion of the selection list. **Applicants must bring their Mobile Phone with the registered mobile number.**

5. **Fees Waiver (Pragyan Bharati Scheme):**

**A. Applicability:**

Category of students eligible under the scheme:

- Students whose parental annual income is less than Rs. 4.00 lakh per annum from all sources or will be eligible to avail this scheme.
- If either of the parent (mother or father) of the student is working in the State Govt./Central Govt./Semi Govt./State or Central Govt. undertakings, such students shall not be eligible under this scheme.
- Scheme is only for regular students having minimum 75% of attendance in classes in previous year/semester with no back paper in previous examination to be eligible for Fee Waiver claim in the subsequent year/semesters of study.

**B. Proof of Income/Documents required:**

**Ration Card issued by the competent authority.**

*If no Ration Card is issued then Income Certificate from the Local Revenue Circle Officer*

- Either of the Income Certificate, so submitted by the candidate will have to be verified by the Competent Authority within one year and action as per Law will be taken against anyone where submission of false Certificate is established.
- A declaration from the students that neither of the parents (father or mother) of the students is an employee of State Govt., Central Govt. Department or its undertaking.
